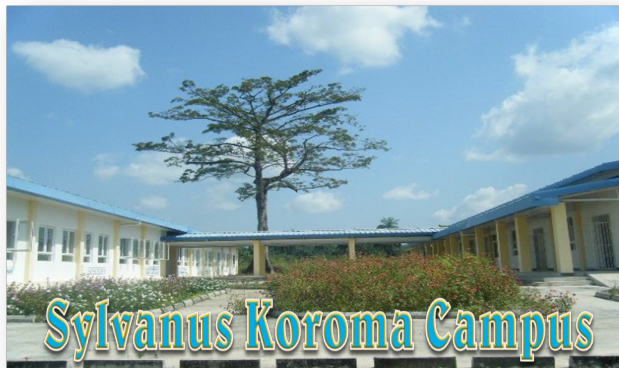

**1. Back Ground and Objectives:**

The University of Makeni Law Department is offering short term courses in Company Law, Employment law Contract and Business Law for middle and senior management personnel of public, private enterprises, and nongovernmental organisations.

The objective of these courses is to equip middle and senior management personnel of private, public and non-governmental organisations with relevant legal knowledge and skills, to engage legal problems efficiently.

The courses will not lead to qualification as a lawyers or legal advisers for private and public entities. However, the knowledge and skills will build the capacity of public and private sector middle and senior management personnel to:

Critically analysis management problems relating to employment law, company law, contract and business law.

Devise sound management solutions to these problems.

Build middle level and senior management personnel's capacity to critically examine management situations and decide whether to seek expert legal advice or not.

Help personnel to understand legal advice, options and opinions, when provided by legal experts for their organisations.

### **Benefits:**

Candidates and organisations participating in these courses will realise the following benefits:

Knowledge and skills in dealing with legal issues relating to employment law, company law, contract and business law  
Increase middle and senior management personnel productivity and efficiency in dealing with employment, company and contractual matters.

Avoid employment disputes and corporate tax liabilities.

Avoid legal actions and its adverse consequences.

### **Method of Delivery:**

The Courses are delivered within a period of 8 weeks. Students are required to attend a three hours class per week from 6: 30pm to 9: 30pm week days.

There will be two hours lectures followed by one hour seminar.

The lectures will introduce the students to the concepts of the subject matter. The seminars are designed to deepen the students understanding of the subject matter, through discussion and practical class exercises.

### **Assessments:**

Students are assessed through practical class exercises, assignments and an end of course exams.

### **Qualifications:**

The successful student will be awarded the University of Makeni non senatorial certificate in the subject area studied. Example a certificate in Employment Law or a Certificate in Business and Contract.
