ABOUT THE COURSE

To account is to use a set of tool kits to document, to explain, to regulate, to generate and to distribute information on the finances of an entity. The evidence of all business transactions and occurrences is collected and stored in certain internal control systems. From these systems, financial information is identified in the accounting systems.

Finally, a notice of the information is put out to users. The major concern is to which extent must an accountant be ethical in the information that he distributes? Below are three basic tasks of an accounting officer:

(1) Identify

This is to give names to activities, events and processes through which an entity's finances are dispersed.

(2) Record

This is to:

- **Classify:** To clarify and manage the information identified
- **Balance:** To align with the information identified

- **Aggregate:** To enroll the information identified

(3) Post

This is an act of service. It is to voice publicly the information identified and recorded on the finances of an entity dispersed via activities, events and processes.
